

Reigate Priory Lawn Tennis Club Coaching Privacy Policy

About this document

We have created this policy to tell you how we use your personal data as a coaching participant of Reigate Priory Lawn Tennis Club's coaching programme.

The legal basis

For the purposes of the General Data Protection Regulation (GDPR) and UK data protection laws, the controller is Russell Dykes, Head Coach of Reigate Priory Lawn Tennis Club Coaching (RPLTCC) C/O. 1 Blenheim Close, London, SW20 9BD.

By signing up to the RPLTCC programme you choose to give us certain personal data such as your name and contact details so that we can use them (Or process them in data protection terminology) for purposes connected with tennis coaching. Your choice gives us legitimate interests under GDPR to process your personal data. We also ask you to check a box when you complete our online coaching application/ camps/ schools coaching application forms confirming that you consent to us processing your data for the purposes of tennis coaching.

How we collect your information

We may collect your personal data in several ways, namely:

- Directly from you, when you fill in a coaching application form, when you interact with us during your coaching sessions and in the best interests of tennis activities at the club (For example, when you enter a tournament or league, volunteer to help at RPLTC junior sessions, sign up for coaching, camps, schools);
- From someone else who has applied for coaching on your behalf (for example a family member who has provided us with your contact details for that purpose);
- From the LTA (for example, where the LTA passes on your details to us in connection with a query or complaint you have raised about our coaching).

The types of information we collect

We may collect the following types of personal data about you:

- Contact and communications information, including your contact details (including email address(es), telephone numbers and email address(es) and records of communications and interactions we have had with you);
- Financial information including payment details;
- Personal details, such as date of birth and any medical conditions that the coaching team need to be aware of to ensure safe delivery of their lessons and to ensure children are appropriately grouped.

How we use personal data

Personal data provided to us will be used for the purposes set out at the time of collection and, where relevant, in accordance with any preferences you express.

More generally, we will use your personal data for the following purposes:

- Administration of the coaching programme, including:
 - Coaching information on junior and senior courses running at Reigate Priory LTC;
 - Regular junior news and items relevant to coaching and playing at Reigate Priory LTC;
 - Communicating the most appropriate courses and events relevant to age and standard;
 - Taking payment of coaching fees;
- Research and statistical analysis about who is taking part in the junior and senior coaching programme;
- Communication about our coaching and club activities that may be of interest to you such as tournaments, leagues, coaching and social activities;
- Providing contact details for junior and senior tournaments and league matches;
- Storing your details on the software platform we use for our coaching management database.
- Promoting RPLTC and promoting goods and services of third parties (for example, equipment suppliers, and organisers of tennis events) where we think this will be of interest to you and where we have your consent, as applicable.

Additional measures to protect the personal data of junior members

When booking a court for an individual lesson on the clubs Clubspark court booking page, we will not display the name of a junior under 16, instead display this as 'Junior Lesson.'

We collect personal data only from the parent/guardian of junior participants under 16.

We require the parent/guardian of a junior under 16 to agree to us processing the junior's personal data when the coaching application or renewal is made.

We do not publish contact information of coaching participants.

Juniors' parents/guardians can withdraw their consent to the publication of photographs connected with playing tennis in any of RPLTCC courses.

Your marketing preferences

We will always respect your wishes in respect of what type of communications you want to receive from us and how you want to receive them. There are some communications, however, that we need to send you regardless of your marketing preferences in order for us to fulfil our obligations to you for tennis coaching purposes. Examples of these essential service communications are:

- Records of transactions, such as payment receipts;

- Coaching payment related mailings such as outstanding payments, RPLTC membership renewal reminders, and information about RPLTC events.

Sharing your information with others

We do not sell or share your personal data for other organisations to use other than as set out below.

Personal data collected and processed by us may be shared with the following third parties, where necessary:

- Our coaching team, for the purposes of administering coaching courses
- RPLTC committee for administering purposes.

How long your information is kept

We keep your personal data only for as long as necessary for each purpose we use it. For most coaching data, this means we retain it for so long as you or your children are actively taking coaching lessons and where required for a period of no longer than five years after your last interaction with us (for accounting, record-keeping purposes).

Your rights

Under certain circumstances, by law you have the right to:

- Request access to your personal data (commonly known as a "data subject access request"). This enables you to receive a copy of the personal data we hold about you and to check that we are lawfully processing it.
- Request correction of the personal data that we hold about you. This enables you to have any incomplete or inaccurate information we hold about you corrected.
- Request erasure of your personal data. This enables you to ask us to delete or remove personal data where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your personal data where you have exercised your right to object to processing (see below).
- Object to processing of your personal data where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground. You also have the right to object where we are processing your personal data for direct marketing purposes.
- Request the restriction of processing of your personal data. This enables you to ask us to suspend the processing of personal data about you, for example if you want us to establish its accuracy or the reason for processing it. You can also withdraw your consent, where this is the basis for our processing your data (without affecting the lawfulness of our previous processing based on consent).
- Request the transfer of your personal data to another party.

Please note that the above rights are not absolute, and we may be entitled to refuse requests where exceptions apply.
